## REGULATIONS

Made by the Commissioner of Police with the consent of the Minister of Transport under section 67(1) of the Motor Vehicles and Road Traffic Act

# THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) (SANGRE GRANDE/EL DORADO) REGULATIONS, 2012

1. These Regulations may be cited as the Traffic Control<sub>Citation</sub> (Experimental Scheme) (Sangre Grande/El Dorado) Regulations, 2012.

2. These Regulations shall have effect from Monday 19th March, Duration 2012 to Monday 18th June, 2012.

#### PART I

# SANGRE GRANDE

3. A person driving a motor vehicle shall not park on—

Parking prohibited

- (a) Brierley Street, between Picton Road and Ojoe Road;
- (b) Foster Road, between Brierley Street and Riverside Complex;
- (c) Old Post Office Road, between Eastern Main Road and Railway Road No. 1; and
- (d) Eastern Main Road, between Andrea Street and George Street on the—
  - (i) southern side on Monday, Wednesday and Friday; and
  - (ii) northern side on Tuesday, Thursday and Saturday.

4. A person driving a motor vehicle shall not stop or wait on the Stopping and northern and southern sides of Eastern Main Road, between Andrea waiting prohibited Street and Ojoe Road roundabout.

5. A person shall not load or off-load a goods vehicle on the Loading and northern side of Eastern Main Road, between Andrea Street and Ojoe  $_{prohibited}^{off-loading}$  Road roundabout.

6. A person shall load and off-load a goods vehicle on the southern Loading and side of Eastern Main Road, between Andrea Street and Ojoe Road off-loading permitted roundabout.

One-way	7. A person driving a motor vehicle shall proceed in—
traffic	<ul> <li>(a) a westerly direction on Eastern Main Road, between Wallenvale Road and Railway Road ("Guaico Junction"), between the hours of 6.00 a.m. to 9.00 a.m. and 2.00 p.m. to 6.00 p.m. Monday to Friday except on public holidays;</li> </ul>
	(b) a southerly direction on Railway Extension Road, between Eastern Main Road and Railway Road;
	<ul><li>(c) an easterly direction on Railway Road, between Railway Road and Eastern Main Road;</li></ul>
	<ul><li>(d) an easterly direction on Brierley Street, between Picton Road and Toco Road;</li></ul>
	(e) a northerly and westerly direction on Henderson Street, between Toco Road and Foster Road;
	<ul><li>(f) a northerly direction on Guaico Village Street No. 1, between Railway Road and Eastern Main Road;</li></ul>
	(g) a southerly direction on Guaico Village Street No. 3, between Eastern Main Road and Railway Road Extension;
	<ul><li>(h) an easterly direction on River Road, between Ojoe Road and Foster Road;</li></ul>
	<ul><li>(i) a northerly direction on Guaico Village Street No. 4, between Railway Road Extension and Eastern Main Road;</li></ul>
	<ul><li>(j) a southerly direction on George Street, between Eastern Main Road and Juteram Street;</li></ul>
	(k) an easterly direction on Canton Street, between Paul Street and George Street;
	<ul><li>(1) a westerly direction on Oxford Street, between George Street and Paul Street;</li></ul>
	<ul><li>(m) a southerly direction on Cunapo Southern Road, between Eastern Main Road and Mary Street;</li></ul>
	<ul><li>(n) an easterly direction on Mary Street, between Paul Street and Cunapo Southern Road;</li></ul>
	(o) a northerly direction on Michael Street, between Eastern Main Road and Brierley Street; and
	<ul><li>(p) a southerly direction on Andre Street, between Eastern Main Road and Cunapo Southern Road.</li></ul>
No entry	8. A person driving a motor vehicle shall not enter Short Street, except maxi-taxis and marked Sangre Grande Regional Corporation vehicles.

# 9. A person driving a maxi-taxi proceeding—

#### No entry to maxi-taxis

- (a) east along Eastern Main Road is prohibited from travelling further east along the route at Paul Street intersection; and
- (b) along Eastern Main Road is prohibited from entering Railway Road No. 1.

10. A person driving a motor vehicle proceeding east along Eastern Left turn only Main Road shall turn left at Railway Road ("Guaico Junction"), between the hours of 6.00 a.m. to 9.00 a.m. and 2.00 p.m. to 6.00 p.m. Monday to Friday except on public holidays.

- 11. A person driving a motor vehicle proceeding— Major/minor road
  - (a) on Brierley Street at its intersection with Ramdass Street, "shall have the right of way; and
  - (b) east on Railway Road and Brierley Street at its intersection with Picton Road, shall have the right of way.

12. A person driving maxi-taxi plying the Toco and Mayaro routes Maxi-taxi shall ply on the southern side of Brierley Street, facing east (east of stand Railway Road No. 1) as marked.

13. A person driving a taxi plying the—

Taxi stand

- (a) Coalmine and Tamana routes shall ply on the southern side of Mary Street, between George Street and Cunapo Southern Road, as marked;
- (b) Biche and Plum Mitan routes shall ply on the eastern side of Cunapo Southern Road (reversing from Mary Street), between Andre Street and the Paint Shop, facing south, as marked;
- (c) Mayaro/Toco route shall ply on the area north of Royal Castle (west of the old Bus Terminal compound), as marked;
- (d) Quash Trace route (Foster Road taxis) shall occupy Foster Road, north of River Road, as marked; and
- (e) Sookram Village/Sangre Grande District Hospital route (Ojoe Road taxis) shall ply on Ojoe Road from Sangre Grande roundabout to Brierley Street and north of River Road as marked.

14. A person driving a maxi-taxi shall not ply for hire on Eastern No plying for Main Road and on Brierley Street, one hundred metres in either <sup>hire</sup> direction from the maxi-taxi stand.

# PART II

#### El Dorado

15. A person driving a motor vehicle shall proceed in a—

- (a) northerly and westerly direction only on Mc Seveney Street Extension, between Persad Street and Mc Seveney Street, from Monday to Friday, between the hours of 7.00 a.m. to 9.00 a.m. and 2.00 p.m. to 4.00 p.m. except public holidays;
- (b) northerly and easterly direction only on Target Road Extension, between College Road and Target Road from Monday to Friday, between the hours of 7.00 a.m. to 9.00 a.m. and 2.00 p.m. to 4.00 p.m. except public holidays; and
- (c) southerly direction on Target Road, between Karamath Street and Target Road Extension, from Monday to Friday, between the hours of 7.00 a.m. to 9.00 a.m. and 2.00 p.m. to 4.00 p.m. except public holidays.
- No left turn 16. A person driving a motor vehicle shall not turn left from College Road onto Target Road, from Monday to Friday, between the hours of 7.00 a.m. to 9.00 a.m. and 2.00 p.m. to 4.00 p.m. except public holidays.

Parking prohibited

- 17. A person driving a motor vehicle shall not park on—
  - (a) Green Street, between El Dorado Road and Balthazar Street, from Monday to Friday, between the hours of 7.00 a.m. to 9.00 a.m. and 2.00 p.m. to 4.00 p.m. except public holidays;
  - (b) Cassie Street, between Caura Royal Road and John King Street, between the hours of 4.00 p.m. and 8.00 p.m. except public holidays;
  - (c) the western side of Macoya Road (south) (adjacent to Macoya Market) from a marked point eighty metres to a marked point two hundred and fifty metres south of the Churchill-Roosevelt Highway; and
  - (d) the eastern side of Macoya Road (south) (adjacent to Macoya Market) from a marked point one hundred and seventy metres to a marked point one hundred and ninety metres south of the Churchill-Roosevelt Highway.

One-way traffic

# General

18. (1) Subject to subsection (2), a person who contravenes any of Offence and the provisions of these Regulations commits an offence and is liable on <sup>penalty</sup> summary conviction to a fine of seven hundred and fifty dollars.

(2) A person who is found guilty of subsequent contravention of any of the provisions of these Regulations is liable on summary conviction to a fine of one thousand dollars.

19. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in  $_{of vehicles}^{impounding}$  contravention of these Regulations may be removed by the Police and  $_{unlawfully}^{of vehicles}$  impounded and dealt with in accordance with section 108(1)(b) of the parked Motor Vehicles and Road Traffic Act.
