REPUBLIC OF TRINIDAD AND TOBAGO Act No. 10 of 2015

AN ACT to provide for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2016

[Assented to 26th October, 2015]

ENACTED by the Parliament of Trinidad and Tobago as $\ensuremath{\mathtt{Enactment}}$ follows:

1. This Act may be cited as the Appropriation short title (Financial Year 2016) Act, 2015.

Issue from the Consolidated Fund authorized

2. (1) The issue from the Consolidated Fund of the sum of fifty-four thousand, seven hundred and sixty-two million, ninety-four thousand, nine hundred and sixty-five dollars (\$54,762,094,965) is authorized for meeting expenditure for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2016, under the Heads of Expenditure specified in the First Column of the Schedule.

(2) The sum specified in the Second Column of the Schedule, in relation to the Head of Expenditure specified in the First Column of the Schedule, is appropriated out of the sum of fifty-four thousand, seven hundred and sixty-two million, ninety-four thousand, nine hundred and sixty-five dollars (\$54,762,094,965) for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2016.

Commencement

3. This Act is deemed to have come into force on the 1st day of October, 2015.
