COMMENCEMENT OF ELECTORAL REGISTRATION PARLIAMENTARY ELECTIONS, 2015

Members of the public including persons already registered, are hereby notified that under Section 30 of the Representation of the People Act Chap. 2:01, His Excellency, the President of the Republic of Trinidad and Tobago has issued a Proclamation fixing Tuesday 14th of July, 2015 as the date for the commencement of an Electoral Registration in the forty-one (41) Parliamentary Electoral Districts in Trinidad and Tobago.

In accordance with the said Section 30 and Registration Rules 52 and 53, the Electoral Registration will be conducted in the various Registration Area Offices and the Temporary Registration Area Offices established for the purpose, during the period Tuesday 14th to Thursday 23rd of July, 2015 excluding the public holiday of Eid-Al-Fitr on Saturday 18th July 2015.

The purpose of the exercise is to facilitate those persons who:

- (1) have attained the age of 18 years and over, but who have not been registered as electors;
- (2) have been registered as electors but have changed their addresses and have not yet notified the Registration Officer of such change of address;

(3) have been registered as electors and have changed their names because of marriage or otherwise, but their previous names appear on the Preliminary List of Electors;

(4) have been registered as electors but their names do not appear on the Preliminary List of Electors.

During the period of the Electoral Registration, business will be conducted at the Registration Area Offices and at the Temporary Registration Area Offices

Monday to Friday: 8:00 a.m. to 6:00 p.m.
Sunday: 9:00 a.m. to 2:00 p.m.

It is important to note that at the close of business on Thursday 23rd of July 2015, no further registration or registration related matters will be effected.
