ORDER

MADE BY THE MINISTER UNDER SECTION 61(1) OF THE TRINIDAD AND  
TOBAGO POSTAL CORPORATION ACT

THE TRINIDAD AND TOBAGO POSTAL CORPORATION  
(VESTING) ORDER, 2015

WHEREAS it is provided in section 61(1) of the Trinidad and Tobago Postal Corporation Act, Chap. 47:02 (hereinafter referred to as “the Act”) that the Minister shall, by Order, on or before 9th April, 2017, vest in the Trinidad and Tobago Postal Corporation (hereinafter referred to as “the Corporation”) such property which was under the direction and management of the Postmaster General under the Post Office Act, Chap. 47:01, at the commencement of section 61(1) at 1st July, 1999:

And whereas it is expedient that certain properties which housed post offices and were under the direction and management of the Postmaster General be vested in the Corporation:

Now, therefore, the Minister in the exercise of the powers vested in him by section 61(1) of the Act makes the following Order:

Citation                    1. This Order may be cited as the Trinidad and Tobago Postal Corporation (Vesting) Order, 2015.

Vesting of properties in the Trinidad and Tobago Postal Corporation                    2. (1) The properties which were under the direction and management of the Postmaster General and are referred to in the Schedule are hereby vested in the Trinidad and Tobago Postal Corporation.

(2) Where the properties have been vested in the Trinidad and Tobago Postal Corporation and it decides to sell those properties, the State shall be given the first option to acquire the properties which housed the post offices located in Cedros, Oropouche, Penal, Morvant, Gasparillo, Tabaquite, Rio Claro, Guaico, Guapo and Couva.
