## ORDER

Made by the Commissioner of Police under Section 68(1) of the Motor Vehicles and Road Traffic Act

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (CEREMONIAL OPENING OF PARLIAMENT) ORDER, 2015

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Ceremonial Opening of Parliament) Order, 2015.

2. This Order has effect from 6.00 a.m. to 6.00 p.m. on Duration Wednesday 23rd September, 2015.

3. Drivers proceeding west along Independence Square South Traffic shall turn north on reaching Edward Street, between the hours of <sup>diverted</sup> 12.00 midday and 3.30 p.m.

4. (1) Subject to subclause (2), drivers are prohibited from Vehicular proceeding along the following roads between the hours of 12.00 midday  $\frac{\text{traffic}}{\text{diverted}}$  and 3.30 p.m.:

- (a) Independence Square South, between Edward Street and Wrightson Road; and
- (b) the westbound carriageway of Wrightson Road, between Independence Square South and Sackville Street.
- (2) Subclause (1) does not apply to—
- (a) the President of the Senate;
- (b) the Speaker of the House of Representatives; and
- (c) Ministers of Government.

5. Persons shall not park on the following roads between the hours Parking of 6.00 a.m. and 6.00 p.m.:

- (a) Wrightson Road;
- (b) Edward Street;

- (c) Independence Square North;
- (d) Independence Square South;
- (e) Richmond Street;
- (f) Dock Road;
- (g) South Quay;
- (h) London Street;
- (i) Post Office Road; and
- (j) Park Street.

Two-way traffic 6. Drivers may proceed in both directions along the eastbound carriageway of Wrightson Road, between Independence Square South and Sackville Street, between the hours of 12.00 midday and 3.30 p.m.

Removal and impounding of vehicles unlawfully parked 7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by a member of the Police Service and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
