REGULATIONS

MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE MINISTER OF WORKS AND TRANSPORT UNDER SECTION 67(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) (SAN FERNANDO/MARABELLA) REGULATIONS, 2015

- 1. These Regulations may be cited as the Traffic Control Citation (Experimental Scheme) (San Fernando/Marabella) Regulations, 2015.
- 2. These Regulations come into operation on Monday 2nd Duration November, 2015 and expire on Monday 1st February, 2016.

PART I

San Fernando

3. A person driving a motor vehicle—

No right turn

- (a) north along the San Fernando By-Pass, shall not turn right at its intersection with Tarouba Road, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays;
- (b) south along the San Fernando By-Pass, shall not turn right at its intersection with Tarouba Road, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays;
- (c) south along Horizon Drive, Bel Air, shall not turn right at its intersection with South Trunk Road, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays;
- (d) east on Connector Road, shall not turn right at Union Hall intersection near Vehicle Management Corporation of Trinidad and Tobago San Fernando Office; and
- (e) west on La Pique Road, shall not turn right at its intersection with Pointe-a-Pierre Road.

Left turn only

- 4. A person driving a motor vehicle—
 - (a) east along Tarouba Road, shall turn left at its intersection with the San Fernando By-Pass between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays; and
 - (b) west along Tarouba Road, shall turn left at its intersection with the San Fernando By-Pass, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays.

Parking prohibited

- 5. A person driving a motor vehicle shall not park on—
 - (a) Carib Street, between Howard Lane and Upper Hillside Street;
 - (b) the southern side of Park Street;
 - (c) Harris Promenade (North), between Penitence Street and Chancery Lane;
 - (d) the northern side of Lord Street, between Coffee Street and Mucurapo Street;
 - (e) the western side of Mon Chagrin Street, between High Street and San Fernando Street;
 - (f) Quenca Street, between High Street and San Fernando Street;
 - (g) the eastern side of Quenca Street, between San Fernando Street and Chacon Street;
 - (h) High Street, between Chancery Lane and Pointe-a-Pierre Road;
 - (i) Independence Avenue;
 - (j) the western side of Penitence Street, between High Street and St. James Street;
 - (k) the western side of Todd Street, between Farah Street and Rushworth Street;
 - (1) the eastern side of Todd Street, between Westwood Street and Rushworth Street; and
 - (m) the northern side of Hobson Street.

Stopping and waiting prohibited

- 6. A person driving a motor vehicle shall not stop or wait on—
 - (a) Circular Road, between its intersection with London Street and to a point fifty metres east; and
 - (b) Carib Street, between Coffee Street and to a point one hundred and eighty metres north.

7. A person driving a motor vehicle shall proceed in—

One-way traffic

- (a) an easterly direction only on Leotaud Street, between Cipero Street and Carlton Lane;
- (b) a westerly direction only on Lawrence Street, between Carlton Lane and Cipero Street;
- (c) a northerly direction only on Henry Street, between Medine Street and Coffee Street;
- (d) a southerly direction only on Mon Chagrin Street, between High Street and San Fernando Street:
- (e) a northerly direction only on Penitence Street, between High Street and St. James Street; and
- (f) an easterly direction only on Harris Street South, between Harris Street and Paradise Street.
- 8. A person plying a taxi for hire along the—

Taxi stand

- (a) San Fernando to La Romaine route shall ply on Coffee Street, in the taxi stand, with a maximum of twelve taxis facing east, as marked; and
- (b) San Fernando to St. John Village route shall ply on the eastern side of Mucurapo Street, in the taxi stand, with a maximum of ten taxis facing south, as marked.
- 9. A person plying a taxi for hire may drop off or pick up a Drop off and passenger on the northern side of Coffee Street, from Prince of Wales pick up permitted Street to a marked point eighty metres north.
 - 10. A person driving a motor vehicle is permitted to park on—

Parking

- (a) the eastern side of Penitence Street, between Harris permitted Promenade (North) and High Street;
- (b) the western side of Todd Street, between Park Street and Farah Street:
- (c) Coffee Street, between Prince of Wales Street and La Coulee Street;
- (d) the northern side of Park Street;
- (e) the eastern side of Mon Chagrin Street, between High Street and San Fernando Street;
- (f) Harris Promenade (South), between Paradise Street and Harris Street;
- (g) the western side of Quenca Street, between St. James Street and Chacon Street; and
- (h) the eastern side of Todd Street, between Westwood Street and Rushworth Street.

No entry to taxis and maxi-taxis

- 11. A driver of a taxi or maxi-taxi shall not proceed—
 - (a) west onto Bamboo Bay Road, Bamboo Drive, at its intersection with Gulf View Drive, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays;
 - (b) south onto Nairn Avenue at its intersection with Naparima-Mayaro Road, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays;
 - (c) south onto Simpson Brown Terrace at its intersection with Naparima-Mayaro Road, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays; and
 - (d) west onto Forres Avenue at its intersection with Naparima-Mayaro Road, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays.

Maxi-taxi stand 12. A person plying a maxi-taxi for hire along the San Fernando/Princes Town route shall ply on the southern side of Coffee Street, between Johnstone Street and Prince of Wales Street with a maximum of nine maxi-taxis facing west, as marked.

Maxi-taxi entry and exit

- 13. (1) A person driving a maxi-taxi, plying the San Fernando/Princes Town route shall exit Coffee Street by turning right only onto Carib Street.
- (2) A person plying a maxi-taxi for hire shall have access to all streets in San Fernando between the hours of 6.00 p.m. and 5.00 a.m. only.

PART II

MARABELLA

One-way traffic

- 14. A person driving a motor vehicle shall proceed in—
 - (a) a northerly direction only on 5th Avenue, Maraj Lands, between Southern Main Road and 4th Avenue, Maraj Lands, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays; and
 - (b) an easterly direction only on 1st Avenue, Maraj Lands, between the hours of 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays.

15. A person driving a motor vehicle shall not park on the—

Parking

- (a) eastern side of Maraj Avenue, on Tuesdays and Thursdays, prohibited except on public holidays; and
- (b) western side of Maraj Avenue, on Mondays, Wednesdays and Fridays, except on public holidays.

GENERAL

- 16. A person who contravenes these Regulations is liable on Offence and summary conviction, in the case of a first offence, to a fine of seven penalty hundred and fifty dollars and in the case of a second or subsequent offence, to a fine of one thousand dollars.
- 17. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in impounding contravention of these Regulations may be removed by a member of the unlawfully Police Service and impounded and dealt with in accordance with parked section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
