Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (TOBAGO JAZZ EXPERIENCE) ORDER, 2015

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Tobago Jazz Experience) Order, 2015.

PART I

Speyside

- 2. This Part shall have effect from midday on Saturday 18th April, Duration 2015 to 2.00 a.m. on Sunday 19th April, 2015.

 - 18. Vehicular traffic is prohibited from proceeding—
