Explanatory Note

The object of the Bill is to supplement the appropriation provided for by the Appropriation (Financial Year 2019) Act, 2018 (Act No. 16 of 2018) by authorising the issue from the Consolidated Fund in the sum of One Thousand, Eight Hundred and Thirty Nine Million, One Hundred and Eighty-Nine Thousand, Three Hundred Dollars (\$1,839,189,300).

ENACTED by the Parliament of Trinidad and Tobago as ${\tt Enactment}$ follows:

1. This Act may be cited as the Finance Short title (Supplementary Appropriation) (Financial Year 2019) Act, 2019.

Further issue of \$1,839,189,300 from the Consolidated Fund 2. A further issue from the Consolidated Fund in the sum of one thousand, eight hundred and thirty nine million, one hundred and eighty-nine thousand, three hundred dollars (\$1,839,189,300) is authorised for meeting expenditure for the service of Trinidad and Tobago for the financial year ending September 30, 2019 and appropriated in respect of the Heads of Expenditure set out in the Schedule to this Act.
